## Coeur d'Alene Basin Restoration Plan

A Draft Environmental Impact Statement (DEIS) has been prepared which assesses the effects of the Coeur d'Alene Basin Restoration Plan on the quality of the human environment in accordance with the provisions of Section 102(2) (c) of the National Environmental Policy Act of 1969 P.L. 91-190 (NEPA).

The U.S. Fish and Wildlife Service and U.S. Forest Service prepared the DEIS on behalf of the Coeur d'Alene Basin Natural Resource Trustees (Trustees) to address the effects of a comprehensive strategic framework to guide the restoration of natural resources injured by the release of mining related hazardous substances in the Coeur d'Alene Basin.

The planning area consists of the 3,840 square mile Coeur d'Alene Lake Basin and the 230 square mile portion of the Hangman Creek watershed on the Coeur d'Alene Tribal Reservation. The area is located primarily in Shoshone, Kootenai, and Benewah Counties, in northern Idaho. A small portion of Bonner County lies at the extreme northern portion of the planning area. Small portions of Latah and Clearwater Counties occur in the planning area at the headwaters of tributaries of the St. Maries River.

Proposed restoration includes actions to restore streams, wetlands, and lakes that have been affected by mining-related contamination. The plan considers restoration of non-contaminated aquatic systems where doing so will benefit recovery of contaminated ecosystems. The plan also proposes to restore or enhance human uses of injured natural resources in the near term while longer-term ecosystem restoration proceeds.
